CRIMINAL JUSTICE RESPONSE IN INDIA

"Cruelty" under criminal law also refers to harassment of the woman with a view to coerce her or any of her relations to meet any unlawful demand of property⁸ By virtue of section 49&4, IPC, if any married woman is subjected to cruelty by her husband and in-laws, they can be punished with imprisonment upto three years and fine
